For New Student enrolments the investment is due with the Offer of Place and Enrolment Agreement. Students are unable to begin at CCMPS until the enrolment investment has been paid in full.

Working Bees/Cultural Day/Material Making/Open Days/Projects/Community Pods – Events/Full Fridge/Gardening/Co-Op etc.

2.4	Notice period required	Week 1 Friday of Terms 2, 4, 6 & 8	The school requires four weeks notice before the end of these terms in writing before the withdrawal of a student or the following FULL 2 term's Tuition investments will be payable in lieu of notice.
